

Evaluation of Polycyclic Aromatic Hydrocarbons (PAHS) Levels in Soil Contaminated with Electronic Waste (E-Waste), South-Eastern, Nigeria

Abstract

E-waste is an emerging environmental problem, as it is composed of a heterogeneous mix of different metals, metalloid, glass and plastic, which are useful and hazardous to the environment. The article aimed at evaluating the levels of Polycyclic Aromatic Hydrocarbons (PAHs) in soil contaminated with e-waste obtained at different depths (0 - 10 cm, 10 - 20 cm & 20 - 30 cm) and the evaluation was done in soil samples with the help of gas chromatograph coupled with a mass analyzer. The concentrations of the 16 Polycyclic Aromatic Hydrocarbons ranged from 404 - 32, 250 µg/kg, There was significant variation in the mean values of the 16 PAHs under study across seasons. At 0 - 10 cm in the dry season, the mean values ranged from 30.0 µg/kg (benzo(k)fluoranthene) High Molecular Weight (HMW) PAHs to 1,675 µg/kg (acenanphthylene) Low Molecular Weight (LMW) PAHs. While in wet season, it ranged from non detectable limit (naphthalene) LMW PAHs to $3,934 \mu g/kg$ (phenanthalene) LMW PAHs. The trend of PAHs percentage distributions was 3-rind PAHs > 7-ring PAHs > 2-ring PAHs > 4-ring PAHs > 5-ring PAHs > 6-ring PAHs. The hazard index HI-non carcinogenic risk for children was > 1 and for adult is < 1. The trends of ILCR concentrations for both children and adults follow ingestion > dermal > inhalation. The PAHs cancer risk in this study revealed moderate to very high level. It can be concluded that the e-waste dumping activities have contributed contaminant of PAHs to the soil. Hence dumping activates should be properly monitored.

1.0 Introduction

In Nigeria, like other countries. **PAHs** contamination via e-waste has spread all over the country. Persistent organic pollutants (POPs) like PAHs are very ubiquitous in nature due to their volatility, and contamination from this source is widespread due to high level of population growth, indiscriminate dumping of e-waste and burning of material containing POPs compounds (Eyenubo et al., 2024). Contamination from ewaste as a result of uncontrolled disposal has become a general health issues in Nigeria since it is associated with hazardous substances. Uncontrolled burning releasing highly toxic fumes which impact on the neighborhood aesthetics, dismantling, and dumping leads to a variety of issues in our environment like the contamination of groundwater, atmospheric pollution and water pollution through immediate discharge or as a result of surface runoff . The rate of growth of domestic and imported e-waste in Nigeria, as reported by researchers, is on the average of 500 shipping containers with 400,000 computer monitors that enter Lagos port, Nigeria per year (Adebola and Peter, 2017).

Persistence organic pollutants like PAHs generated from e-waste accumulate in the soil as a result of their poor water solubility and strong chemical stability (Xi, et al., 2022), other sources like particulate matter from the atmosphere can increase the concentration of PAHs in the soil via sedimentation, as such soil is known to be a major source of PAHs in the environment that affects plants, animals and humans health (Liu et al., 2018, Xi, et al., 2022). Pollution generated by PAHs has become a major environmental challenge across the world as a result of their potential carcinogenic, tetratogenic and mutagenic effects (Cao, et al., 2019, Xi, et al., 2022). Waste from electronics generally known as e-waste is a generic term referring to those electrical electronics equipment that becomes obsolete or disposed of by the original users; phones, television, computer monitors, laptops, printers, scanners with their associated wiring (Khadijah, 2016). Emerging environmental issues like e-waste, composed of a heterogeneous mix of different metals, metalloids, glass and plastics from which some valuable metals such as aluminum, copper, gold, silver and iron are recovered via recycling which serve as environmental sustainability management (Robinson, 2019). Different hazardous nickel substances like (Ni), lead (Pb)(PBDEs), plybrominated diphenyl ethers polyaromatic hydrocarbons (PAHs), polychlorinated biphenyl (PCBs) etc has been released into the environment due to the inability to monitor the dumping of e-waste (Eyenubo, et al., 2022)

Improper practices of e-waste disposal and dismantling like open dumping, open burning, acid baths and heating of circuit boards, have led to the emission and release of hazardous pollutants, including heavy metals, persistent organic pollutants (POPs), and volatile organic pollutants (VOCs) (Shengtao, et al., 2021). During the past two decades, several research studies have been done on the environmental occurrence and fate, transformation and potential adverse health consequences of these hazardous chemicals from e-waste sites (Shengtao et al., 2021). They found that dismantling employees and resident houses near the e-waste sites are exposed highly through dermal contact, inhalation and ingestion with this hazardous material, toxic fumes and toxic chemicals from contaminated soil, water and food. E-waste are exposed to environmental dismantlers pollutants via inhalation which is one of the



important exposure pathways (Shengtao, et al., 2021).

The e-waste generates a large volume of toxic substances that affect the ecosystem. The material composition of e-waste contains various substances which are known to be hazardous and non-hazardous (Richard et al.. 2013). Occupational exposure **PAHs** to in Epidemiological studies has shown that they can generate induction of skin and lung cancers. Report have also shown that some PAH metabolites interact with deoxyribonucleic acid (DNA) and are genotoxic, generating malignancies and heritable genetic problems in humans (Adebola et al., 2017). Lower molecular weight PAHs like naphthalene, fluorene, phenanthrene and anthracene (2 to 3 rings) generated significant acute toxicity to aquatic organisms, on the other hand higher molecular weight PAHs like chrysene and coronene (4 to 7 rings) do not generate acute toxicity, but are carcinogenic (Adebola et al., 2017). The Food and Agriculture Organization of the United Nations and the Intergovernmental Technical Panel on Soils reported that many of world's soil resources will only be in better condition with 33% of the land resources being moderately to highly degraded (Panatda et al., 2023). The dumping, recycling and even burning of e-waste lead to the leaching of toxic metals into the soil which then affect humans through ingestion or direct dermal exposure, combustion of e-waste at low temperature released toxic chemicals such as PAHs (Adebola and Peter, 2017). Limited information has been reported on the transformation and distribution of PAHs from ewaste dumpsite in Nigeria, but PAHs are lipophilic and accumulate in food chains associated with the contaminated dumpsites (Oliveira et al., 2014, Adebola and Peter, 2017). There are several studies of PAH contamination in soil contaminated with e-waste in decades dumpsite associated with burning and other refuge, currently there is no comprehensive seasonal variation analysis of PAHs in soil contaminated with e-waste without combustion and other interfering refuge in Nigeria. Hence this study is to evaluate levels of PAHs in soil obtained from an impacted e-waste dumpsite free from interference of other refuge, ascertaining the level of pollution the e-waste has impacted on the soil at tender age of 2 years.

2.0 Material and Methods

2.1 Description of the study Area

Abraka is a University town and is one of the most developed areas in Ethiope East Local Government Area of Delta State, Nigeria. South-South, The town is bounded at the north by Obiaruku, at the south by Salubi in Eku, at the west by Edo state and at the east by Aragba Orogun. Abraka has low topography, and its geographical location is Latitude 06.23'01 450 N and Longitude 007.73'09 800 E. The town has an annual rainfall of 2324 mm.

2.2 Collection and preparation of Soil samples

A piece of land of 8 feet by 8 feet was impacted with an electronics waste for the period of 2 years, free from interference of other refuge. Eighteen soil samples were collected to form a composite of 9 samples at 0 - 10 cm, 10 - 20 cm and 20 - 30 cm. for each season, from an impacted dumpsite in Abraka communities from December – February (dry season) and May – July (wet season). A stainless hand held soil auger was used to collect the samples. Thereafter, they were conveyed to the laboratory, dried for 7 days, pulverized with mortar and pestle, sieve with 2 mm mesh sieved and then stored in a deep freezer at -20° C prior to further analysis.

2.2.1 Analytical Procedures

Three steps were involved in the determination of PAHs in samples collected from the dumpsite and these are extraction, purification/ fractionation of the chromatographic separation and quantification.

2.2.2 Samples Extraction

10 g of the stored soil samples was mixed with 10 g of anhydrous sodium sulfate; 5 g aliquot was extracted three times by sonication with 15 ml of dichloromethane (1:1) in 20 min. Then there was concentration and fractionation of the



organic extract as water sample after centrifugation.

2.2.3 Extract clean - up

This was done with strong acid, thereafter partitioning was carried out with florisil; 2 ml of concentrated sulphuric acid was mixed with 1 ml of the extract with thorough shaking to avoid coextract interfering. The whole exercise was done severally until a colourless was observed in the acid phase. The extract was dried with anhydrous sodium sulfate before fractionation with florisil. The packing of the glass column was done with 10 g of florisil (60 - 100 mesh) with addition of 2 g of anhydrous sodium sulfate at upper part of the column to eliminate any amount of water present. 1 ml of the extract was inserted into the column followed by the elution of PAHs with 80 ml of hexane. The concentration of elute was carried out with a rotary evaporator and a gradual nitrogen stream. 1 ml of hexane was used to dissolve the PAH fraction and conveyed to vials of chromatograph awaiting gas gas chromatography analysis. GC – MS analysis was done in single ion monitoring (SIM) mode for assessing and quantifying of PAH congeners.

2.2.4 PAHs Congeners Determination

PAHs determination was done in soil samples with the help of Hewlett-Packard 7890 gas chromatograph coupled with a Hewlett Packard Model 5975 mass analyzer: quadrupled and automatic sampler. The column made up of fused silica capillary was a 30 m DB - 1 m (100% dimethylsiloxane) (CJ & W Scientific, CA, USA) $(0.25 \text{ mm i.d. } x 0.25 \text{ } \mu\text{m of the thickness of film}).$ The temperature of the oven was initially programmed at 100 °C (standing for 1 min) – 325 °C at the ratio of 15 °C/min and last for 5 min. The conditions under which the gas chromatograph was carried out were 250 °C injection temperature and 280 °C transfer line temperature. Helium is used as a carrier gas through a steady flow count of 1.2 ml/min, with an elevated oven temperature of 120°C for 0.5 min to 210 °C at 30 °C/min to 6 °Cmin for 5 mins. The running conditions of the mass spectrometer were 250 °C used for transfer line and ionization source temperature, 70 eV is used ionization voltage, the time used for scanning was 0.3s with 0.5s scanning delay and 5 min delay solvent. Statistical analysis for all data obtained were done using Microsoft excel (Microsoft Inc., USA) and SPSS 22.0 (SPSS Inc., Chicago II., USA).

2.2.5 PAHs Identification and Quantification

The analyzed compounds identification was based upon the ion ratio, the spectra and the retention time which was done by an internal standard procedure using peak areas. The MS analysis was done using single ion monitoring mode where by 2 masses were monitored in the mass spectrum. The chromatogram retention time shift was corrected with the use of internal standard retention time and agreement of about \pm 0.1 min of the retention time expected, for the positive confirmation of the analyte. The linear range of the detector, were evaluated by preparing several standard solutions which are injected at various concentration. The calibration curves are within the range of 10 - 200 ng/ml, the correlation coefficient (r^2) was above 0.999 for all compound analyzed.

2.3 Human Health Risk

2.3.1 Non-carcinogenic risk assessment using Hazard Index (HI)

The hazard index of PAHs in the soils was evaluated by using the USEPA standard methods assuming the three major routes of exposure; ingestion, dermal and inhalation (IDI) (USEPA, 2011). The hazard index was calculated from the summation of the individual hazard quotients through each route of exposure. The evaluation of the hazard index in terms of IDI was carried out by using the equations below.

where CDI_{ing}, CDI_{inh}, CDI_{dermal} are the chronic daily intake or dose contacted through ingestion, inhalation and dermal contact with soil respectively. RfD is the reference dose, RfD_{ing} (chronic oral reference dose), RfCinh (chronic inhalation reference concentration), RfD_{dermal} (chronic dermal reference dose = $RfD \times ABS_{GI}$) through the three exposure pathway, CSFing is the chronic oral slope factors via ingestion, IUR is the chronic inhalation unit risk, ABS is dermal absorption factor, PEF is soil to air particulat emission factor, AT_{nc} is average time for non carcinogenic and C is the concentration of PAHs in soil. Hazard index value less than 1 indicate there is no adverse non-carcinogenic risk while

hazard index value greater than 1 indicates the presence of adverse non-carcinogenic risk (USEPA, 2011).

2.3.2 Carcinogenic risk assessment using Total Cancer Risk

Like the hazard index, total cancer risk of PAHs in the soil samples was evaluated by using the USEPA standard methods assuming the three major routes of exposure; ingestion, dermal and inhalation (IDI). The total cancer risk was calculated from the summation of the individual risks through each route of exposure. The equations and parameters for the evaluation of the total cancer risk are shown below.

where, AF is soil to skin adherences factor BW is average body weight, ED is exposure duration, EF is exposure frequency, ET is exposure time ATca is average time for carcinogenic, CfS_{ing} is chronic oral slope factor via ingestion and C is the concentration of PAHs in soil respectively. Generally, total cancer risk value 1×10^{-6} is also considered the carcinogenic target risk (USEPA, 2011, Luo *et al.*, 2012). Total cancer risk value

less than 1×10^{-6} indicate no cancer risk but greater than 1×10^{-6} indicates the presence of adverse cancer risk.

2.4 Quality Assurance and Data Analysis

Blank sample analysis with recoveries of surrogate standard for each sample was done as a monitoring measure for all procedures. Each batch (4 per batch) was run with blank across all analytical phases. The mean recoveries for all the PCBs congeners were calculated. For extraction purpose, 10 g of muscle tissue and 2 g of soil were used to extract the PAHs. The data analysis was done with Microsoft excel Inc., USA by evaluating the principal component analysis, Pearson's correlation analysis, and assessing the relationship between the contaminant, the mean, median and standard deviation. The detection and quantification limit (LODs & LOQs) were determined with the ratio of 3 and 10 for signalto-noise for all the concentrations, which ranged from 0.003 - 0.013 mg/kg (LODs) and 0.01 -0.04 mg/kg (LOQs). From all the PCBs investigated, the blank were totally cleared. Calibration was done via injections of standard solutions of mixed PAHs at 6 concentration level.

3.0 Results and Discussions

The concentrations and statistical variations of PAHs with respect to months and depths are presented in Tables 2 and 3. The percentage distribution of PAHs on the soil collected from the e-waste dump site across depths and months is presented in Figure 2. Individual PAHs concentrations (Table 2) were analyzed for six months (3-months dry season and 3-months wet season). It was observed that high concentration of the individual PAHs with respect to depths and months were prominent in January and December at 0 - 10 cm and 10 - 20 cm for lower molecular weight (LMW) (naphthalene, PAHs acenaphthylene, acenaphthene, fluorine. anthracene and phenanthrene), which ranged from 78.0 μ g/kg - 3588 μ g/kg. The non detectable limit observed in some depths in February, May, June and July for LMW PAHs might have been evaporated from the soil as a result of their high volatility (Nganje et al, 2014).

The highest PAHs concentration $(6,144 \ \mu g/kg)$ was observed in phenanthrene at July for LMW PAHs and in fluoranthene at July (6,712 μ g/kg) for higher molecular weight (HMW) PAHs. The trend of concentration across months was that high concentrations occur in wet season than in wet season across low and high molecular weight PAHs. These higher concentrations might be ascribed to too much deposit of these PAHs from the e-waste to the soil. Table 3 displays significant variation in the mean values of the 16 PAHs under study across the seasons. At 0 - 10cm in dry season, the mean values ranged from 30.0 µg/kg (benzo (k) fluoranthene) HMW PAHs to 1,675 µg/kg (acenanphthylene) LMW PAHs. While in wet season, it ranged from non detectable limit (naphthalene) LMW PAHs to 3,934 µg/kg (phenanthalene) LMW PAHs. At depths 10 - 20 cm in dry season, the values varied from non detectable limit on both high and low molecular weight PAHs to 2,068 µg/kg

(fluoranthene). At depth 20 -30 cm in dry season, the values ranged from 98.7 μ g/kg (benzo (g), h, i) perylene to 890 μ g/kg (phenanthrene, while in the wet season, the values varied from non detectable limit to 802 μ g/kg (pyrene). In all, the highest mean concentration was observed in the wet season. The mean and median values displayed relative closeness across depths and season, which implies that the data set was normally distributed. The percentage distribution of the 16 PAHs was presented in Figure 2.

The 2- ring PAHs constitute below detectable limit to 70.41 % (10 – 20 cm) at February of \sum 16, the PAHs, 3 – ring PAHs constituted 1.81% (0 – 10 cm) – 92.2 % (20 – 30 cm) at June, 4 – ring of below detectable limit to 68.28 % (10 – 20 cm) at May. The percentage distribution of the 5-ring PAHs constitute below detectable limit – 53.38 % (10 – 20 cm) at July and the percentage distribution for the 6 – ring of \sum 16 PAHs constitute below detectable limit – 27.69 % (10 –



20 cm) at January, while for 7 Ring PAHs, also constitute from below detectable limit to 88.7 % (0 - 10 cm) at May. The highest percentage was observed in the wet season at 10 - 20 cm and there is no definite trend in the percentage distribution across depths and months. The trend of PAHs percentage distributions was 3-rind

PAHs > 7-ring PAHs > 2-ring PAHs > 4-ring PAHs > 5-ring PAHs > 6-ring PAHs. The highest percentage observed in the wet season might be ascribed to rainfall and the poor drainage system of the site. The calculated PAHs hazards index in this work is displayed in Table 4.

The hazard quotient values for HQ_{ing} ranged from 0.08 in December at depth 20 - 30 cm to 5.18 in July at 0 - 10 cm depth, HQ_{inh} values ranged from 9.30×10^{-6} in January at 0 - 10 cm to 5.20×10^{-3} in May at 10 - 20 cm and HQ_{dermal} values ranged from 0.01in February at 20 - 30 cm to 1.88 in July at 0 - 10 cm for children. While for adult, HQ_{ing} values ranged from 2.00×10^{-3} in June at 10 - 20 cm to 0.32 I July at 0 - 10 cm, HQ_{inh} values ranged from 3.00×10^{-5} in January at 0 - 10 cm to 0.03 in December at 10 - 20 cm and HQ_{dermal} values ranged from 3.00×10^{-5} in January at 0 - 10 cm to 0.03 in December at 10 - 20 cm and HQ_{dermal} values ranged from 3.00×10^{-5} to 0.14 across depths and months. The hazard

quotient follows the trend of $HQ_{ing} > HQ_{dermal} > HQ_{inh}$ for both children and adult. The total non cancer risk for children spanned from0.05 at February to 7.06 at July, while for adult, the values ranged from 0.01in February to 0.06 in July of which both follows the same trend. The hazard index obtained for children was > 1 in some depths and months, indicating that there is non- carcinogenic risk with PAHs exposure in this work at across some depths and months. While for adult, the hazard index is < 1 indicating that there is non-carcinogenic risk associated with PAHs exposure across depths and months.

The ILCR across soil depths and months via ingestion, inhalation and dermal for children and adult were presented in Table 5, the recorded values spanned from 1.43×10^{-3} to 3.05×10^{-1} (ingestion), 3.29×10^{-11} to 6.57×10^{-9} (inhalation), 8.96×10^{-4} to 7.79×10^{-2} (dermal) and 1.83×10^{-5} to 2.50×10^{-3} (ingestion), 1.12×10^{-10} to 2.40×10^{-8}

(inhalation), 4.44×10^{-5} to 9.57×10^{-3} (dermal) across depths and months for both children and adults. The trends of ILCR concentrations for both children and adults follow ingestion > dermal > inhalation. The total cancer risk across depths and months ranged from 2.25×10^{-3} to 4.16×10^{-1} and 6.49×10^{-5} to 1.11×10^{-2} for both



children and adults of which the total cancer risk for adults is lower than that for children. This might be as a result of the high tendency of dermal contact of children with soil particles (Emoyan, 2020). Considering the life time cancer risk based values classified by New York State Department of Health (NYS DOH, 2007), ($\geq 10^{-4}$ = very high, $> 10^{-3}$ to 10^{-1} =high, $\geq 10^{-4}$ to 10^{-3} = moderate, $\geq 10^{-6}$ to $10^{-4} = \text{low and} \leq 10^{-6} = \text{very}$ low). The PAHs cancer risk observed in this study indicate moderate to very high level for both children and adults. Since the values of cancer risk in this study are greater than approved value of 1×10^{-6} , this implies that the dump site is subject to generation of cancer to human via ingestion and derma contact routes.

Table 6, displayed the estimated BaP equivalence (BaP_{TEQ}) and mutagenic equivalence (BaP_{MEQ}) values in relation to exposure to PAHs in soil obtained from e-waste dumpsite which spanned from 13.5 – 3,372 µg/kg, with significant contribution from BbF, BaP, DahA and IndP. The highest BaP_{TEQ} value was observed in May at depth 20 – 30 cm which shows that those PAHs contents penetrate into the soil due to rainfall and the poor drainage system of the site. While the lowest value was observed in February at 20 - 30 cm depth which indicate high

penetration ability and strong binding capacity of the soil to the PAHs contaminants. These values were similar to those reported by Chukwujindu *et al.* (2019) in a similar study. The values of BaP_{MEQ} observed in this study ranged from 18.6 – 2,704 µg/kg, the significant contribution of these values was also obtained from BbF, BaP, DahA and IndP as in the case of BaPTEQ. These values corroborated the report of Emoyan (2020). The PCA results of PAHs in the soil are presented in Table 7. Four components were found and accounted for 90.111 % of the variability in the data. Component 1 accounted for 31.902 % of the total variance and was characterized by high positive loading of Phen, Flt, Chry, BaA, BkF, IndP and DahA. BaA, Chry, BkF and DahA are indicators for dieselpowered engines (Wang *et al.*, 2013; Yu *et al.*, 2014).

Component 2 explained 22.649 % of the total variance and was characterized by high positive loading of Nap, Pyr, BaP and BghiP. Nap is a tracer for incomplete combustion processes (Yu et al., 2014) while BaP and BghiP are indicative of automobile emissions (Liu et al., 2017; Iwegbue et al., 2017). Component 3 explained 19.109 % of the total variance and was characterized by high positive loading of Ace, Acy and Flu and moderate loading of Phen. These compounds are indicative of low temperature combustion processes such as burning of wood/biomass and liquidified petroleum gas, natural gas and coal (Guo et al., 2003; Wang et al., 2013). Component 4 was characterized by high positive loading of Ant and BbF and moderate loading of Nap and Chry and accounted for 16.451 % of the total variance. Nap is related to incomplete combustion processes while Ant, Chry and BbF are tracers of coal combustion (Dong and Lee, 2009). All numbers appearing bold shows that those compounds generate the highest concentrations among the 16 PAHs under considerations. Figure 3 displays a significant and highly significant correlation between the sixteen (16) PAHs congeners at p < p0.05 and p < 0.01 levels. These correlations across the 16-PAHs at dry season certified the presence of hydrocarbon congeners with each other and gave a clear knowledge and insight of the PAH congeners on the surface of the soil. Phenanthrene (Phe) showed more positive correlation in relation to all other compound of PAHs, while Benzo (a) anthracene (BaA) showed a more negative correltion in relation to all other compounds of PAHs. The non-correlation observed implies that there is no significant effect with their persistence in the soil surface.



Figure 4 shows a strong, significant correlation (p < 0.01) between the sixteen (16) PAH congeners across all compounds, except for Anthracenc (Ant), during the wet season compared to the dry season. The correlation level here certified the presence of hydrocarbon across each compound which gives a better understanding and a better

insight into PAHs congeners' movement within the soil surface. The non-significant correlation observed at Anthracene (Ant) might be an indication that there is no significant effect with the persistence of Ant congeners across the soil surface.

4.0 Conclusion

Due to the increase rate in dumping activities, ewaste contaminated soil deserved much concern handle. highest to The PAHs mean concentrations were observed in wet season with relative closeness to the median values, the highest percentage distributions were also observed in wet season across depths. The hazard quotient follows the trend of HQ Ing > HQ Derm > HQ Inh., for both children and adult and the total cancer risk for adult is lower than that of children in ths study. It can be affirmed that ehas waste dumping contributed much contaminants of PAHs to the soil. Hence proper legal action in observing the environment should be put in place to avoid indiscriminate dumping of e-waste.
