

### Agro-Products and Raw Materials Development-A Review of applications in Nigeria

#### Abstract

Over the years, agro-products have served as foundational resources for the development of various raw materials, with ongoing research continually uncovering novel applications. These materials include methanol, nanomaterials, lignin, cement additives, cellulose, and agro-based enzymes, highlighting their immense industrial and economic potential. Beyond their viability, the utilization of agro-products mitigates environmental issues by converting agricultural waste into valuable raw materials, thereby reducing pollution. Nigeria, endowed with abundant crude oil, natural gas, and other mineral resources, relies heavily on these for foreign exchange despite its vast agricultural potential. This review explores Nigeria's agro-based raw materials, their geographic distribution, and industrial applications, emphasizing their chemical and physical properties. The study underscores the importance of leveraging these resources to spur the establishment of small-scale agro-allied industries, fostering economic diversification and sustainable development.

#### **1.0 Introduction**

With the rapid increase in world population, which currently stands at 7.7 billion with an annual growth rate of 1.05% and a projection of reaching 9.7 billion by 2050 (UN World Population Prospects, 2019), much pressure has been exerted on the existing raw materials for the production of value-added products. The emergence of new technologies, which warrant the exploitation of new frontiers in industrial development for new products and processes, also increases the demand for raw materials.



Thus, it becomes imperative to search for alternative or supplementary raw materials that can effectively and efficiently replace the existing ones.

Raw materials are unprocessed materials that can be processed into many useful products. It is one of the determinants of a product's quality and cost (Makio *et al.*, 2003). Raw materials are supplied in powder and liquid forms. Processing of raw materials, such as grinding and, mixing is very important. A lot of factors could affect the quality of raw materials, such as impurities, moisture contents, particle shapes, particle size and size distribution, etc. (Isreal *et al.*, 2016).

Raw materials can be considered as crude or processed substances that undergo transformation for the production of valueadded products. As the name implies, raw material development entails the creation of raw materials from sources that were not initially in use or the manufacturing of raw materials from novel materials. In the quest for these alternative sources of raw materials, it demands that attention be given to the environmental impact of such materials, the economic viability, sustainability, the availability of technology that can convert such raw materials into the needful products, government policy that guides the usage of such materials, etc.; all these boil down to the new concept in the engineering discipline called the 'Green Engineering Practices'. With this current trend in the engineering practices, raw material development focuses now on sources that are renewable.

In order to stall and overcome Nigeria's excessive reliance on its oil and gas sector for national development, as well as expand the economy's growth, it is vital to harness its mineral and agricultural resources (Adindu *et al.*, 2014). Therefore, this paper discusses raw material development and utilization as criteria for Nigeria's economic development. This serves as a first step in strengthening its entrepreneurship and small and medium

enterprises (SMEs) development. The aim of this study is to evaluate agro-based raw materials in Nigeria, their availability, where they can be found in abundance, their applications and value addition for economic growth. The most abundance agro-products are considered in this work.

# 2.0 Agricultural Potential of Nigeria and Government developmental Polices

Nigeria has approximately 71 million hectares of farm land available for cultivation representing 77% of the total land mass in the country. It is estimated that out the available cultivable land. 84% of the land is owned by the farmers either by purchasing or transfer of ownership from ancestors, 11% is leased to farmers by owners, 4% is leased by third party or the farmer pays royalties and 1% is illegally cultivated. The land Use Act according James (1978) states that, lands in the urban area are owned by the State Government while lands in the rural area are owned by the Local Government. This Act put a check to land usage. In term of manpower, out of over 213 million people in the country, more than 70% are involved in one agricultural practice or the other, there are estimated 18.17 million crop farmers, 12.30 million livestock farmers, 6.39 million poultry farmers and 1.02 million fishery farmers.

To improve agricultural potential of the country, In December 2021, Nigeria Government formulated medium-term National Development plan that covers a period of 5 years (2021 -2025). This was done to unravel its potential in all sector of the economy for holistic national development and increasing agriculture production for economic growth by the year 2025. This developmental plan gave birth to Agricultural National Technology and Policy (NATIP) Innovation (2022-2027)formulated by Federal Ministry of Agriculture and food Security which aims at promoting agro-based industries by increasing productivity and quality of products in agricultural sub-sector



through infrastructure and financial availability. (Data Collection Survey on Agriculture Sector in Nigeria (2024). This step was taken by the government to boast agro-products availability for human consumption and for industries purposes.

## 3.0 Types of raw materials

Raw materials for all production processes are from diverse sources, which are basically from nature. The synthesis, processing, and transformation of materials into secondary raw materials take its bases from the natural sources; thus, nature is the bedrock for all raw materials (Marschallek and Jacobsen 2020).

A basic classification is the nature of how the good is extracted. These classifications include: Mined raw materials extracted from the earth, such as ores, stones, metals, minerals, lime, sand, soil, oil, and coal; Plant-based raw materials come from trees or plants, including fruits, nuts, flowers, vegetables, resins, wood, cotton, and latex, and Animal-based raw materials are extracted from animals such as milk. leather. meat. furs. and wool (https://www.investopedia.com/terms/r/rawmat erials.asp).

Manufacturers also have their ways of classifying raw materials. Their classification is based on the extent in which the material has been used in the cause of production of the desired product. On this premise, raw materials are classified into two broad categories; the direct raw materials and the indirect raw materials. The direct raw materials are those materials that form the bases through which finished products are produced. Example includes woods for furniture, leather for bags, wool for cloth, silicon oxide for glass, etc. All these materials form the bedrock and the primary components of the final products. The indirect materials are those materials raw that complement the production of the desired products. Examples are gum, nails, metal hoop, glue, lining used in cloth making, etc. These materials facilitate the coupling of the direct raw materials.

Among all these sources of raw materials mentioned in the first classification above, natural deposits are the most exploited and used raw materials for production processes for both secondary raw materials and value-added products. The reason is that they are obtained directly from the source, and as such, complex technology is not involved. But with the explosion of the human population and the industrial revolution, the demands for raw materials to cater for the increase also increase, coupled with the fact that natural deposits are non-renewable. This called for the search for alternative sources, which has been focusing on agro-products.

Nigeria's short-to-medium-term potential lies in her natural comparative advantage, namely resource-based industries, which will provide a competitive platform for finished products in the longer term, as well as an immediate market for resource input industries.

#### 4.0 Agro–products

Agro-products are those products obtained from agricultural inputs. By extension, agro-based raw materials are simply materials derived naturally from plants and animals (Israel et. al., 2016).

It includes both plant and animal products. Examples include fruits, seeds, nuts, silks, bulbs, grains, latexes, gum, fat and oils, meat, hides and skin, residues of all kinds etc. According to records as reported by Searle (2013), about 1.3 billion tons of food produced, globally representing one-third of annual food production is wasted. 25–50% of vegetables and fruits are usually lost from farm to fork, together called post-harvest losses (Ray, 2022). European Union food waste alone stands at about 59 million tons every year (Eurostat, 2024). 39% of these losses are incurred during processing



handling and storage levels (Mmereki *et al.*, 2024). However, in most African countries (such as Nigeria) food is primarily wasted at the consumer level mainly at caterers, restaurants, and cafeterias. eateries and above all, by households (Orhorhoro *et al.*, 2017; *Oelofse et al.*, 2021).

Aside from the losses incurred from the edible agricultural materials, which posed major environmental challenges through means of disposal. The plant and animal residues, such as cobs from maize, husks from rice, bagasse from sugarcane, bones, blood, etc., also posed a serious environmental challenge because all these materials contained essential nutrients that are major food for microbes, rodents, and other dangerous organisms; thus, they act as breeding grounds for these organisms. If these wastes are not controlled, it can lead to disease outbreaks, pollution various levels. and other at environmental degradation, thus the need to control their disposal. It is in the search for proper waste management of these agricultural products that researchers found out that these materials can be converted to useful materials as alternative sources of raw materials for chemical and biological processes. Table 1 highlights some agro-products and their residues.

# 5.0 Agro-products Availability and Location in Nigeria

Nigeria is blessed with varieties of agroproducts distributed across the six geopolitical zones of the country. The distribution of these products is based on climatic conditions of the various zones which support production of these products. For this study some important agroproducts are consider, their availability and where it can be found in the country. They are classified into five categories (cereal and Tuber crops, vegetable crops, crops for processing, livestock and diary and Aquaculture) as described by Japan International Agency Cooperation in Data Survey of Agriculture sector in Nigeria (April, 2024). Additionally, timber is also considered as it plays a vital role in raw materials development in the country. The map in Figure 1 shows the different geopolitical zone in the Nigeria as stated in the legend.

# 5.1 Cereal and Tuber crops

Table 2 shows the availability of most abundance cereal and tuber crops and zones they are cultivated with yam and cassava taken the lead in tube crops while maize and rice take the lead in cereal crops. They are other crops in this group that are not in abundance but they are also distributed in the different zones of the country according to Federal Republic of Nigeria Data Collection Survey on Agriculture Sector in Nigeria Quarterly Crop Baseline Survey (QCBS) final report of 2004.

#### 5.2 Vegetable crops availability

National Report of Wet Season Agricultural Performance in Nigeria, 2021 is a bar chart showing the amount of common and most



abundant vegetable crops in thousands of tons available in the country and the different zone in which they are cultivated. From the Chart in Figure 2, it can be deduced that the most abundant vegetable crop in the country is cowpea.

These crops are not the only vegetable crops, others are distributed in various zones in the

country and are still very useful for different applications.



# 5.3. Crops for processing

Crops for processing are those that are converted into secondary products before being used. There are several crops in this category, but the most abundant ones are considered in this study. Figure 3 shows their distribution across various zones of the country, with groundnut leading and being most commonly cultivated in the North Central and North East zones, followed by oil palm in the South-South and South East zones

#### 5.4. Livestock and Dairies

Aside from their consumption, these agroproducts are also useful for various industrial applications, such as the manufacturing or processing of secondary products like leather, clothing, and food additives. The most common and abundant livestock and dairy animals in the country are highlighted in Figure 4, where a bar chart shows that chicken is the leading and most abundant in the North West and North Central zones. In addition to the livestock and dairy animals mentioned, others, such as donkeys, horses, and dogs, are distributed across various zones in the country.

# 5.5 Aquaculture availability

To supplement the available aquatic products, farmers also undertake fish production in

artificial environment (pond). Two major products in this category that performed optimal in artificial habitat are the cat-fish and tilapia. Figure 5 highlights amount being produced in different zones of the country.

#### 5.6. Timber

There are approximately 2,300 tree species in Nigeria that are commercially important. These trees are found in all the geopolitical zones of the country ranging from the short shrub in the savanna region to gigantic trees in the mangrove forest. Some example of these trees includes Iroko, Opepe, Afara, Obeche, Abura, Mahogany, Teak, etc. They are very essential agro-product that have wide applications in structural and non-structural uses. (Maiguru et al., 2022).

#### 6.0 Agro-processing

Agro-processing can be defined as the transformation of products originating from agriculture to final products (Swai et al., 2019). Such products include maize, fruits and vegetables, wood, sugarcane, cotton, oilseeds, sunflower seeds, wheat, rice, tea, coffee, skin, milk etc. Agro-processing occurs through

primary as well as secondary processing 2016). (Wanniarachchi et al., Primarv processing involves the preservation of raw materials that are to be used in the final processing. This type of processing can be done either through drying, shelling and grading and does not alter the shape and contents of materials significantly. On the other hand, however, secondary processing involves transforming these materials completely to new products. Examples of secondary processing involve extracting juices from fruits and vegetables, processing cotton to get oil, crushing sunflower seeds to extract oil etc. (Ampadu et al., 2015).

#### 7.0 Materials and Methods

The materials and methods used in the review were obtained from previous literature seen in related journal articles.

# **7.1.** The potential of agro-products residues as raw materials

Many studies have been performed recently to investigate the potential of agro-products as sources of raw materials for the manufacturing of useful products and as means for effective management of wastes associated with the agro - products. The first phase of this noble venture is the characterization of these materials to ascertain their composition so as to know where these materials can be effectively utilized. Some of the agro - product characterizations are highlighted below.

## 7.1.1 Oil palm bunch ash

Palm oil bunch ash is obtained from the burning of waste palm oil bunch and has been found to contain several useful elements. That shows close likeness to conventional cement. The composition and physical properties of palm fruit ash are as given in Table 3.

# 7.1.1.2 Application of Oil palm fruit bunch Ash

Oil palm fruit ash is used in acidic soil treatment and as fertilizer for crops. Ogbuehi, (2016) reported increase in soil P<sup>H</sup> from 5.22 to 6.87 when oil palm bunch ash was used in treating acidic soil. It can also be used as substitute for commercial basic catalyst in biodiesel production and other chemical reactions. The high calcium oxide content also suggests that it can be used as additive to increase the compressive strength of concrete. Thus, the used of palm bunch ash in agro-sector for soil quality improvement and construction companies as additive to cement, help in increasing crop yield and reduce construction cost respectively.

# 7.1.2 Sugarcane bagasse ash

When sugarcane bagasse was burned, it was found to contain useful compounds in good percentage. The percentage composition of different components and basic physical properties are as shown in Table 4.

# 7.1.2.1 Application of sugarcane bagasse ash

It is an essential raw material in paper and pulp industries and also as cement replacement and blending due to its high pozzolanic characteristics. The high silicon oxide content



also suggests its usage in ceramic manufacturing.

#### 7.1.3 Rice husk ash

Rice husk ash has been found to contain over 90% of amorphous silica (SiO<sub>2</sub>) and some other elements. Table 5 shows the chemical compositions and some physical properties of rice husk ash.

#### 7.1.3.1 Application of rich husk ash

Rice husk ash is used as insulating powder in steel production. It is also used in food

processing industry as bio-adsorbent in vegetable oil refining and removal of heavy metal from food materials. In brick manufacturing, it is used as additive to reduce cost of production due to its high pozzolanic index. Other usages include, base material for silica and silicon compounds, as organic fertilizer for quality improvement etc. (Patil et al., 2018; Zou, 2019).

#### 7.1.4 Bamboo leaf ash

The composition and physical properties of bamboo leaf ash are as stated in Table 6. From Table 6 it can be deduced that silicon oxide has the highest percentage in the ash.

#### 7.1.4.1 Application of bamboo leaf ash

Bamboo leaves ash is use in Construction Company as partial replacement of cement and as stabilizer for soft soil treatment. The high silicon oxide content also suggests that it can be used for production of silicon and silica-based compounds (Olutoge *et al.*, 2017).

Other agro-residues have been examined by several researchers to ascertain their composition and where they can be effectively used. Table 7 gives some common residues and their chemical composition.

#### 7.2 Cellulose as Agro-product

Cellulose production is one the recent focus on raw materials development because of its wide range of usages. It is an organic polymer making up approximately 40% of plant cells. It has high molecular weight unbranched chain homo biopolymer with repeating glucose unit attached together by 1 - 4 glycosidic bonds. One end is hemiacetal functionality (Moon et al., 2011). The three major types are Alpha cellulose, Beta cellulose and Gamma cellulose. Generally, the structure of cellulose is complicated due to the different arrangement of the cellulose chain, which varies from one source to another. It comprises of three hydroxyl groups in each monomer glucose with а degree of polymerization ranging from 1000 to 1500 depending on the source of the cellulose. Tables 8 and 9 give some common sources through which it can be extracted.

#### 7.2.1 Application of Cellulose

It has wide range of applications. Its usage cut across industries like construction industry, pharmaceutical industry, food industry, textile industry, pulp industry, cosmetic industry, biotechnology industry. Table 10 highlights some types of cellulose and where they can be used according to Hadi *et al.* (2021).

Many other types of cellulose are in used for various industrial applications and for synthesis of other raw materials for different categories of industries. There are other potential substances yet to be derived from cellulose backbone.

#### 7.3 Enzyme from Agro-products

Several studies also showed the production of enzymes from agro-products. The production of these enzymes is facilitated by the use of appropriate microorganisms. The list of enzymes produces by agro – products are inexhaustible, some common ones are as stated in Table 11.

#### 7.3.1 Applications of Enzymes

Enzymes play vital roles in many industrial processes either as a catalyst, modifier, additives or raw material for production of value-added products. Some of its sources and applications are given in Table 12.

# 7.4 Agro- Products as Source of Nanoparticles



Agro-products especially plants, have been used recently to develop nanoparticles for various purposes. The use of plants for the synthesis of nanoparticles has been assessed to be economical, ecofriendly, less technologically required, etc. Nanoparticles derived from agrosource have advantage in medical applications as they are biocompatible and non – toxic. Several plants have been investigated to assess their potential as sources of nanoparticles. Some of the verified sources are highlighted in Table 13.

#### 7.4.1 Applications of Nanoparticles

Nanoparticles are novel materials synthesized from agro-products; they have wide application in various industrial processes, both as raw materials and as additives. Some sources and applications are as stated in Table 14.

# **8.0** Other Agro- products and their applications

The applications of agro-products for industrial purposes are inexhaustible. Its usage cuts across all industrial sectors, including the oil industry, biomedical, pharmaceutical, and many other industries. Substances like methanol, cellulose, hemicellulose, lignin, bio-nanoparticles, etc. have been found to be very useful in the production of secondary raw materials; they act as the bases in which other secondary raw materials are developed. Presently, research is

ongoing for the development of novel raw materials for the advancement of industrial processes and the optimization of the existing ones. Other raw materials from agro-products and their usages are highlighted in Table 19- 21.

#### A. Methanol

Methanol is a primary alcohol which can be obtained from anaerobic digestion of agricultural waste or gasification of forestry



waste. It is very essential agro-product for production of secondary raw materials. It uses cut across industries like pharmaceutical industry for antiseptics and drugs production, agro-industry as solvent for pesticide and herbicide, paints and coating industry, production of acetic acid, etc. Table 15 give a breakdown of some of the primary and secondary raw materials obtained from methanol used in different industries.

#### **B.**lignin

Lignin is a very important agro-chemical obtained from wood; it is used as both primary and secondary raw materials in the production of various industrial chemicals for cosmetic industry, paper and plywood production, in agro-industry for soil amendment, fertility etc. in construction industry as insulation materials and composite etc. Some of the various chemical obtained from lignin are given in Table 16.

#### C. Biochar

Biochar is charcoal-like material produced from the pyrolysis of biomass. Their various sources and some applications are as stated in Table 17.

# 9.0 The challenges of agro-raw materials development and the way forward

Agro-raw materials development faces enormous challenges which required multifacets approach to tackle in order to boast agroproducts availability which in turn would increase availability of agro-raw materials for industrial purposes. Some of the challenges affecting agriculture in Nigeria include climate change, soil degradation, water scarcity, price accessibility, volatility, financial limited technical expertise, inadequate infrastructure, limited technology access, poor quality control, the country dependence on external agro-input such as improve seed, fertilizer, drugs for livestock and agro-chemicals. In the area of policies, government have made good policies toward creating enabling environment for farmers in the country, but the problem lies in the implementation of these policies. There are not enough instruments on ground for the actualization of these polices making it obsolete after formulation. These challenges militate agro-raw materials availability in the country.

Thus, to cater for these challenges, it is imperative for government to put appropriate machineries in place for effective implementation of its policies at each phase so as to achieve the aim in which the policies were made for. Regular retraining of farmers in new farming technology is also very essential in boasting agricultural out-put. Over the years farmers are still practicing old methods of crops cultivation using poor farmer input and this affect their output greatly. In the area of technology, government and private sector should be kind enough to set-up companies for manufacturing of farm machines and equipment to lower the cost of importation; this would make it affordable to farmers. Sponsoring of agricultural base research is also necessary as it would enable in development of improve varieties of crops and livestock. Another area in which government can improve agro-product availability is by partnering with countries that are using improve technology via exchange programmes, this would afford farmers the opportunity of learning new methods of farming. If these challenges are duly tackled, it would go long way in boasting agro-raw materials availability for industries without contention with food security.

# **10.0** Conclusion

of Agro-products are important sources alternative raw materials for industries. Many studies in the past two decades have shown the conversion of agro-products to raw materials for types industries. virtually all of The development of agro-products into essential raw materials is in progress, although with some challenges of yield maximization, this called for the need to develop a new route or optimize the existing one so as to produce enough raw

materials to cater for the ever- increasing demand in the industries. Also, there is a need to increase cultivation of food crops so as to checkmate food shortest as a result of utilization of food crops as raw materials.
