

# Assessment of Radionuclides Uptake by Melon (*Cucumeropsis mannii*) Seeds from Selected Farms in Akwa Ibom State, Nigeria

### Abstract

Plants and animals (including humans) are vulnerable to ionizing radiation in many ways. One of these ways is through the food chain. This research aimed at assessing the radionuclide uptake by melon seeds from soil, and the effect of ionizing radiation in humans due to melon. The activity concentrations of natural radionuclides in soil and melon seed samples from twenty locations in the study area was conducted using a Gamma ray spectrometric system coupled with a NaI(Tl). The soil samples were quartered and put in the oven at  $50 - 70^{\circ}$ C for 1440 minutes in order to obtain a constant weight. The melon seeds were ground, dried and weighed.

The samples were packaged into labeled nylon bags before being moved to the laboratory for analysis. The average activity concentrations of <sup>40</sup>K, <sup>238</sup>U and <sup>232</sup>Th in soil samples were 397.56±7.61 Bq.kg<sup>-1</sup>, 17.37±0.29 Bq.kg<sup>-1</sup> and  $62.98 \pm 1.02$  Bq.kg<sup>-1</sup> respectively. The average activity concentrations of <sup>40</sup>K, <sup>238</sup>U and <sup>232</sup>Th in melon samples were  $521.49\pm8.47$  Bq.kg<sup>-1</sup>, 15.50±1.67 Bq.kg<sup>-1</sup> and 28.753±0.69 Bq.kg<sup>-1</sup> respectively. The average values of absorbed dose rate, external and internal hazard indices, radium equivalent, annual effective dose rate and representative level index were 46.40 Bq.kg<sup>-1</sup>, 0.26 and 0.30 Bq.kg<sup>-1</sup>, 93.12 Bq.kg<sup>-1</sup>, 0.057 mSv.y<sup>-1</sup> and 0.730 Bq.kg<sup>-1</sup> respectively, for melon samples, while for soil samples, were 63.65 Bq.kg<sup>-1</sup>, 0.37 and 0.42 Bq.kg<sup>-1</sup>, 138.04  $Bq.kg^{-1}$ , 0.078 mSv.y<sup>-1</sup> and 1.01  $Bq.kg^{-1}$ respectively. The average values of the transfer factors of  ${}^{40}$ K,  ${}^{238}$ U and  ${}^{232}$ Th were 1.3693 (49%),



1.0041 (36%) and 0.4721 (15%) respectively. The regression analysis indicated nonlinearity between radionuclide concentrations in soil and that of melon seeds. Hence, the radionuclide concentrations in soil and melon seeds are not proportional.

### **1. Introduction**

The earth is replete with ionizing radiation. This ionizing radiation is produced by both man made and natural radionuclides and is the major source of external and internal irradiation (Hutchison and Hutchison, 1997). The natural radionuclides, <sup>232</sup>Th and <sup>238</sup>U and <sup>40</sup>K are found in large quantities in the earth's crust and these radionuclides account for 96.1 percent of the total annual radiation doses the populace receives, while the remaining percentage is from artificial sources (UNSCEAR, 1993: 2000). The human body functions maximally when it is supplied with adequate nutrients. These nutrients are derived from food crops and animals. The radionuclides in the farmlands enter the roots of the crops. The radionuclide uptake from soil to food crops is defined by the transfer factor (TF). TF is an important model used for vaticinating activity concentration in food crops and assessing dose risk to the populace (IAEA, 2000). Melon seeds are locally called egusi in some parts of Nigeria or ikon in most part of Akwa Ibom State. Nutrients such as carbohydrates, vitamins, fibres, proteins, minerals and biologically active substances can be derived from eating melon seeds (Schippers, 2000; Olaniyi, 2008). Melon seeds, when ground to a particular degree of fineness, are used for many purposes (NRC, 2006: Schippers, 2000). Radionuclide concentrations in soil can likely show the level of contaminants in melon seed grown in such, soil but they are unable to determine the radiological

effect on people consuming the melon seeds. Thus, it is necessary to estimate the radiation dose to individuals consuming the melon seeds. The radiological hazards in connection with the intake of radionuclides in the human body are in direct proportion to the total doses transmitted by the radionuclides as they are stored in different parts of the body (Shukla *et al.*, 1982). Therefore, the present study assessed the radionuclide uptake from soil to melon seeds grown in selected farmlands of Ikot Ekpene, Ikono and Ini Local Government Areas of Akwa Ibom State, Nigeria.

This study is significant because there is no data on the activity concentrations of <sup>40</sup>K, <sup>238</sup>U and <sup>232</sup>Th in melon seeds anywhere in literature for the study locations. Thus, the data would serve as baseline and a basis to assess any future changes on the activity concentrations in melon seeds for Ikot Ekpene, Ikono and Ini Local Government Areas of Akwa Ibom State, Nigeria.

# 2. Materials and Methods

# The Study Area

Figure 1 shows the map of Akwa Ibom State indicating the study areas (LGA) and the sampling locations where this research was conducted. The coordinates of the sampling locations indicated on the map are presented in Table 1.

# Sample Collection and Preparation

The soil samples were collected close to the roots of the mature melon crops on the farm land using weeding hoes, since melon crops have a shallow root system, in accordance with the method employed by Agbalagba and Onoja (2011). The soil samples were exposed to air before being put in the oven at 50 - 70°C for 1440 minutes in order to obtain a constant weight. The melon seeds, after extraction from the pulp and shell, were ground dried and weighed. The samples were packaged into labeled nylon bags and taken to the laboratory for analysis. In the laboratory,



each sample was transferred into an already enable the buildup of radionuclides in the beaker washed beaker and sealed for twenty- nine to before placing it in the shielded detector.

# Sample Analysis

The prepared samples were analyzed for specific activity concentrations of <sup>40</sup>K, <sup>238</sup>U and <sup>232</sup>Th at Centre for Research the Energy and Development, Obafemi Awolowo University, Ile Ife, Nigeria, using thallium-doped sodium iodide (NaI(Tl)). Volume source IAEA-385 was used for efficiency calibration, while <sup>241</sup>Am, <sup>60</sup>Co, <sup>22</sup>Na and <sup>137</sup>Cs point sources were used for energy calibration of the detector. The detector was shielded with lead in order to avoid interference with background radiation from the environment. The detector used Genie 2000 as its operating software in the analyses of various energies of <sup>40</sup>K, <sup>238</sup>U and <sup>232</sup>Th. The counting time for each sample was 36000 s.

#### **Absorbed Dose Rate (D)**

The absorbed dose rate due to  $\gamma$ - radiation of <sup>238</sup>U, <sup>232</sup>Th and <sup>40</sup>K was calculated using Equation 1 (UNSCEAR, 2000).

where  $S_{U_1} S_{Th}$  and  $S_K$  are the specific activities of  $^{238}U$ ,  $^{232}$ Th and  $^{40}$ K, respectively.

#### **Hazard Indices**

The radiological hazard index reflecting the external exposure is called the external hazard index  $H_{ex}$  defined by Equation 2 (UNSCEAR, 2000).

Also, the internal exposure to radionuclides is expressed by the internal hazard index,  $H_{in}$ , which is given by the Equation 3 (Raad and Hayder, 2011).

For radiation hazard to be negligible, values of the indices  $(H_{ex}, H_{in})$  must be less than unity.

#### **Radium Equivalent**

Radium equivalent is a model that takes into consideration the radiological hazards accompanying the activity levels of <sup>238</sup>U, <sup>232</sup>Th and <sup>40</sup>K (Equation 4) (UNSCEAR, 2000).

where  $S_{U}$ ,  $S_{Th}$  and  $S_{K}$  represent the specific activities of  $^{238}$ U,  $^{232}$ Th and  $^{40}$ K, respectively.

#### Annual Effective Dose Rate (AEDR)

The annual effective dose rate (mSv.yr<sup>-1</sup>) was

calculated using Equation 5.

where D is absorbed dose rate due to  $\gamma$ - radiation of  $^{238}$ U,  $^{232}$ Th and  $^{40}$ K (Equation 1).

#### Representative Level Index $(I_{\Upsilon})$

The representative level index  $(I_{Y})$  is derived from Equation 6 (Ahmed and El-Arabi, 2005). It values must be less than or equal to one for the exposure to be within the permissible limits of safety. Thus,  $I_{\gamma} \leq 1$  can be compared to annual effective dose less than or equal to 1mSv, while



 $I_{\gamma} \leq 0.5$  can be compared to annual effective dose less or equal to 0.3 mSv (Turhan *et al.*, 2008).

# **Transfer Factor**

The ratio of plant activity concentrations ( $S_p$ ) to those of soil ( $S_s$ ) is what is referred to as transfer factor (TF). It is a very useful tool for estimating radiation hazards to human beings when the affected crop plant is in contact with the body by way of eating the food crops or using it as ointments. The soil-to-melon seed transfer factors of  $^{40}$ K,  $^{238}$ U and  $^{232}$ Th were estimated using Equation 7 (IAEA, 2010).

where  $S_p$  is the activity concentration of radionuclides in plant (Bq.Kg<sup>-1</sup>) and  $S_s$  is the activity concentration of radionuclides in soil (Bq.Kg<sup>-1</sup>).

# **3. Results and Discussions Radionuclide Activity Concentrations**

The specific activity concentrations S (Bq.kg<sup>-1</sup>) of  ${}^{40}$ K,  ${}^{238}$ U and  ${}^{232}$ Th in the samples analyzed were obtained from Equation 8 (Awudu *et al.*, 2010; Faanu *et al.*, 2011).

where *N* represents the net peak area of the radionuclide,  $\xi$  represents the detector energy dependent efficiency, t represents the counting live time (s),  $\gamma$  represents the gamma ray yield per disintegration of the nuclide, and *M* represents the mass (kg) of the sample.

Table 1 shows the radionuclide activity concentrations of <sup>238</sup>U, <sup>232</sup>Th and <sup>40</sup>K in soil and melon samples collected from Ikot Ekpene, Ikono and Ini Local Government Areas of Akwa

Ibom State, Nigeria. Forty samples were analyzed (twenty soil samples and twenty melon seed samples). The average activity concentrations of <sup>238</sup>U, <sup>232</sup>Th and <sup>40</sup>K in melon samples were 15.50±1.67, 23.75±0.69 and 521.49±8.47 Bq.kg<sup>-1</sup> respectively. The average radionuclide activity concentrations for <sup>238</sup>U,  $^{232}$ Th and  $^{40}$ K in soil samples were 17.37±0.29, Bq.kg<sup>-1</sup> 62.98±1.02 and 397.56±7.61 respectively. The average activity concentration of <sup>40</sup>K in soil calculated was observed to be higher than that obtained elsewhere (Al-jundi et al., 2003; Dowdel et al., 2003; Avadhani et al., 2005; Santawamaitre et al., 2010; Agbalagba and Onoja, 2011; Avwiri and Ononugbo, 2012; Essen et al., 2021; Essiett et al., 2022 and Ejoh et al., 2023) but lower than that obtained by UNSCEAR, (2000); Sarkar et al., (2011) and Tyovenda et al., (2022). The variation may likely be due to geological formation and the nature of manure used, since the study locations were farmlands.

The average activity concentrations of <sup>232</sup>Th in soil obtained in this study was also observed to be higher than that obtained elsewhere (UNSCEAR, 2000; Al-jundi et al., 2003; Dowdel et al., 2003; Avadhani et al., 2005: Santawamaitre et al., 2010; Agbalagba and Onoja 2011; Avwiri and Ononugbo, 2012; Essen et al., 2021; Essiett et al., 2022 and Ejoh et al., 2023) but lower than that obtained by Sarkar et al., (2011) and Tyovenda et al., (2022). While the average activity concentrations of <sup>238</sup>U in soil obtained in this study was seen to be lower than that obtained elsewhere (UNSCEAR, 2000; Aljundi et al., 2003; Dowdel et al., 2003; Avadhani et al., 2005; Santawamaitre et al., 2010; Agbalagba and Onoja 2011; Sarkar et al., 2011; Avwiri and Ononugbo, 2012; Essen et al., 2021; Essiett et al., 2022 and Tyovenda et al., 2022). The variation may be due to geological formation. The average activity concentrations of



<sup>40</sup>K in melon seeds obtained in this study were observed to be higher than those obtained in cassava (Amakom et al., 2017; Ejoh et al., 2023), Afang (Essiett et al., 2022), cucumber (Rand et al., 2021) but lower than <sup>40</sup>K in pumkin leaf (Essen et al., 2021). The average activity concentrations of <sup>238</sup>U in melon seeds obtained in this study were observed to be lower than those obtained in cassava (Amakom et al., 2017) and pumpkin leaf (Essen et al., 2021) but higher than those obtained in Afang (Essiett et al., 2022) and cucumber (Rand et al., 2021). The average activity concentrations of <sup>232</sup>Th in melon seeds obtained in this study were also observed to be higher than those obtained in Afang (Essiett et al., 2022) and cucumber (Rand et al., 2021) but lower than <sup>40</sup>K in pumpkin leaf (Essen et al., 2021) and cassava (Amakom et al., 2017). These disparities in specific activity concentrations of  $^{40}$ K,  $^{238}$ U and  $^{232}$ Th in the food crops are largely due to the individual crop's affinity for the

radionuclides and their uptake (UNSCEAR, 2000).

Figure 2 shows the graphs of <sup>40</sup>K activity concentrations in melon  $(k_m)$  and soil  $(k_s)$ samples against sample locations, with distinctively higher K<sub>m</sub> concentrations in most locations except at Abia okpo and Ibong. Figure <sup>238</sup>U graphs shows the of activity 3 concentrations in melon  $(U_m)$  and soil  $(U_s)$ samples against sample locations with slight variations except at Atai essien while Figure 4 shows the graphs of <sup>232</sup>Th activity concentrations in melon (Th<sub>m</sub>) and soil (Th<sub>s</sub>) samples, indicating high Th<sub>s</sub> at most locations except at Mbiafun. Figures 5 - 7 show the regression analyses with  $R^2$  values of 0.095, 0.002 and 0.051 for ( ${}^{40}K_s$ ,  $^{40}$ K<sub>m</sub>), ( $^{232}$ Th<sub>s</sub>,  $^{232}$ Th<sub>m</sub>) and ( $^{238}$ U<sub>s</sub>,  $^{238}$ U<sub>m</sub>) in soil and melon samples respectively; the high activity concentrations of <sup>40</sup>K, <sup>238</sup>U and <sup>232</sup>Th in soils do not give rise to high activity concentrations of  $^{40}$ K,  $^{238}$ U and  $^{232}$ Th in melon seeds.

# **Contour Map**

Contour maps were produced using the coordinates of sampling points, the activity concentrations of  $^{238}$ U,  $^{232}$ Th and  $^{40}$ K in the samples and the Surfer software program. The contour maps highlight the activity distribution of  $^{238}$ U,  $^{232}$ Th and  $^{40}$ K in melon and soil samples in the study area (Figures 8 - 13). These contours were used to presage the specific activity concentrations in locations within the three LGAs not sampled.

# **Transfer Factor**

Transfer factors range for  ${}^{40}$ K,  ${}^{238}$ U and  ${}^{232}$ Th from 0.89 to 2.16, 0.32 to 1.57 and 0.27 to 1.22 respectively (Table 2). It was observed to be in the order  ${}^{40}$ K >  ${}^{238}$ U >  ${}^{232}$ Th. This agrees with other studies (Essen *et al.*, 2021; Essiett *et al.*, 2022 and Tyovenda *et al.*, 2022). The observed result is due to the fact that the radionuclide uptake from soil to plant is element-specific and facilitated by the radionuclide, similar to plant essential nutrients. Therefore, the high values observed for the  ${}^{40}$ K could be a result of its





similarity to the stable potassium which is one of the important elements needed for effective growth in plants. Most transfer factor values obtained were found to be less than one, aside from  $^{40}$ K. The use of melon seeds obtained from the study locations in whatever form may not subject users to elevated radiation doses since the level of radionuclide contamination is minimal, notwithstanding high transfer values of  $^{40}$ K (Jibiri *et al.*, 2009). The average contribution (%) of <sup>40</sup>K, <sup>238</sup>U and <sup>232</sup>Th to the transfer factor in the studied samples is shown in Figure 14.

#### **Radiological Hazard Indices**

Tables 3 and 4 show the calculated values of absorbed dose, external and internal hazard indices, radium equivalent, annual effective dose rate and representative level index due to activity concentrations of <sup>238</sup>U, <sup>232</sup>Th and <sup>40</sup>K in soil and melon samples, respectively.

Figure 15 shows the absorbed dose rate (nGy.h<sup>-1</sup>) for soil and melon seed at different sample locations in the study area. It indicates that those absorbed dose rates for soil samples were higher than that of melon and, also in some locations, were higher than the recommended safety standard. Hence, farmers in these locations are at higher risk of expose dose of radiation and should take precautionary measures to limit their exposure. In Figure 16, the radium equivalent for soil and melon seed were compared with the recommended safety limit. This shows that the

radium equivalents for the samples were lower than the recommended safety limit. Representative level index for soil and melon seed were compared with the recommended safety limit (Figure 17). This indicates that locations in the study areas with representative level index higher than the recommended safety limit are at risk of elevated ionizing radiation due to soil. The radiological hazard indices in this research agree with other works (Essen *et al.*, 2021; Essiett *et al.*, 2022; Tyovenda *et al.*, 2022).

#### 4. Conclusion

Naturally occurring radioactive materials (NORMs) can be found in the materials that make up the environment which are air, water, soil, food and even humans. The radionuclide uptakes by melon seeds from selected farms in Akwa Ibom State have been assessed. Activity concentrations of natural radionuclides in soil and melon samples from twenty locations in the study area have been evaluated. The average activity concentrations of <sup>40</sup>K, <sup>238</sup>U and <sup>232</sup>Th in melon samples were observed to be higher than other food crops analyzed by other authors while the average activity concentrations of <sup>40</sup>K, <sup>238</sup>U and <sup>232</sup>Th in soil samples agree with averages obtained by other researchers and are found to



below the recommended safety levels. The average values of absorbed dose rate, external and internal hazard indices, radium equivalent, annual effective dose rate and representative level index for both soil and melon samples were within tolerance. The average transfer factor contributions of  ${}^{40}$ K,  ${}^{238}$ U and  ${}^{232}$ Th in the samples were 49%, 36% and 15% respectively. The regression analysis indicated nonlinearity between radionuclide concentrations in soil and those of melon seeds. Hence, the radionuclide concentrations in soil and melon seeds are not proportional. The average value of transfer factor for <sup>40</sup>K was found to be higher compared to other radionuclides. However, potassium is an abundantly available element in the body and the body has a way of mitigating its effect. Hence, the consumption of melon seeds from the study area may not pose a radiological risk to the consumers.
